The fund is an actively managed income portfolio that invests mainly in nominal and inflation-linked government bonds and corporate bonds. The portfolio invests predominantly in domestic bonds. The investments normally to be included in the portfolio will comprise a combination of assets in liquid form and a combination of nominal, inflation-linked and corporate bonds as well as interest-bearing securities, including loan stock, debentures, debenture bonds, money market instruments, corporate debt and nonequity securities. The portfolio may also invest in participatory interests or any other form of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.
