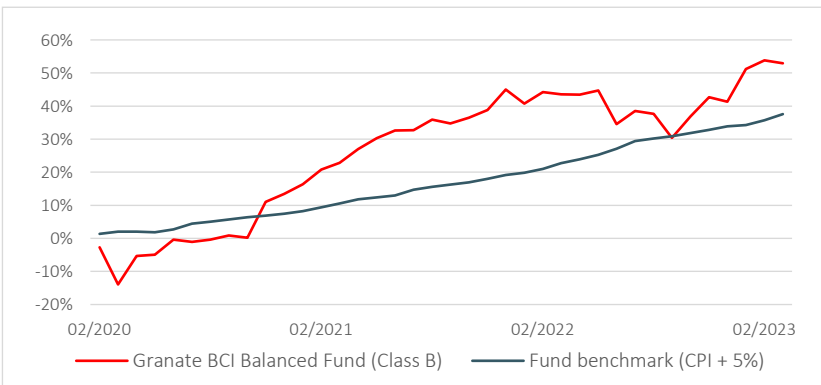
## Investment objective

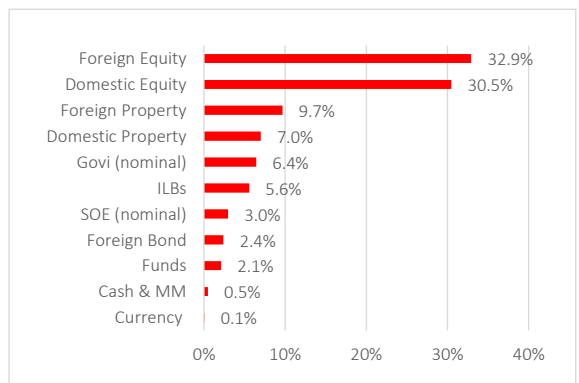
