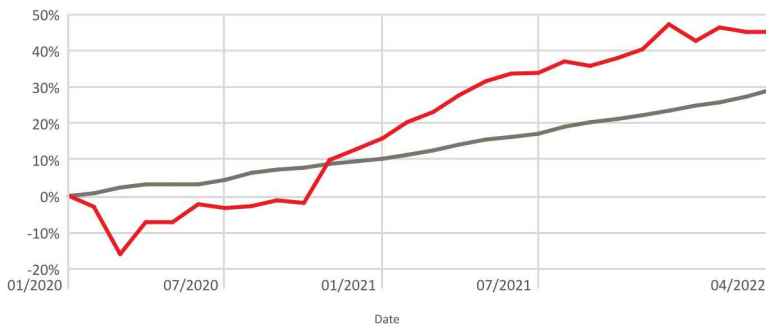
The Granate BCI Flexible Fund's objective is to provide investors with medium to long-term capital growth.

INVESTMENT POLICY

The portfolio aims to achieve a return of at least CPI + 6% per annum, measured over rolling 7-year periods. Whilst it seeks to limit downside risk over the medium to long term, investors should be able to withstand short-term volatility. To achieve these objectives, the portfolio shall have maximum flexibility in terms of asset allocation and shall not be precluded from continually varying its exposure to the various asset classes. The investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, notes, equity securities, property securities, preference shares, convertible equities and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

RISK PROFILE

Moderate - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio.
