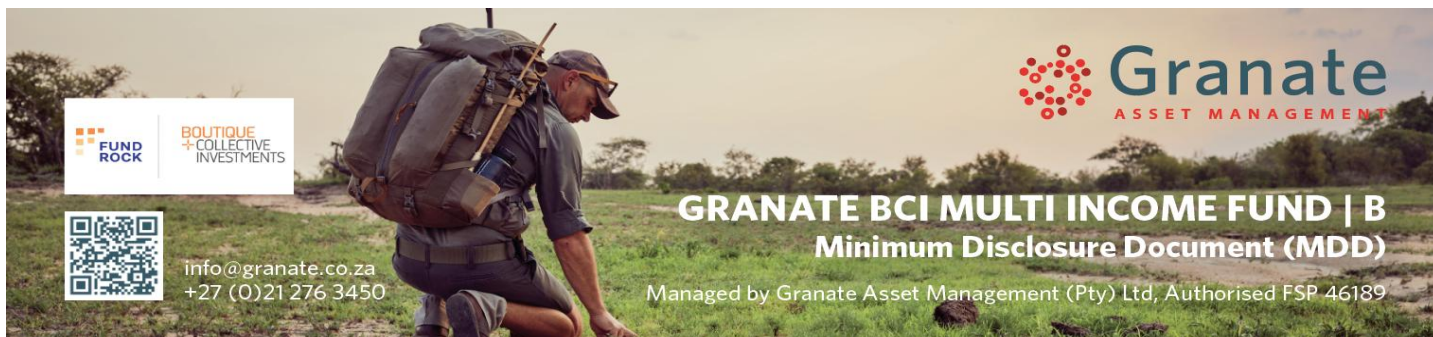


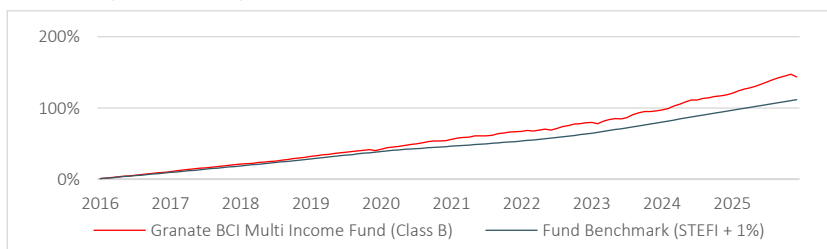

INVESTMENT OBJECTIVE AND POLICY

The Granate BCI Multi Income Fund aims to provide consistent positive returns and minimal volatility. Given that the portfolio aims to deliver consistent positive returns, it is designed to be less volatile than traditional bond funds, with significantly fewer negative monthly returns. The portfolio is flexible and nimble, and diversified across the various fixed income sub-asset classes. It utilises duration, but moderately so, i.e. it will not be a binary portfolio defining position. The portfolio focuses mainly on credit and yield-enhancing strategies, i.e. while employing very moderate duration strategies. In order to achieve its objective, the investments normally included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest-bearing securities, bonds, debentures, corporate debt, equity securities, notes, property securities, preference shares, convertible equities and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments. Maximum equity exposure is 10% of the portfolio's net value. The fund objective is to outperform money market and traditional income portfolios over the medium to long term.

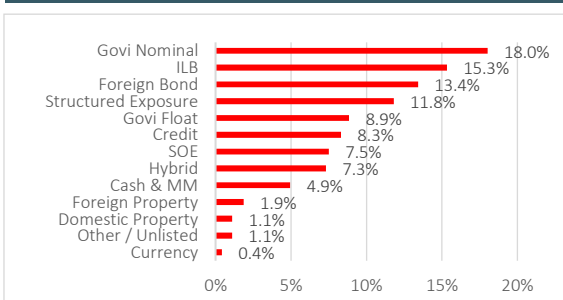

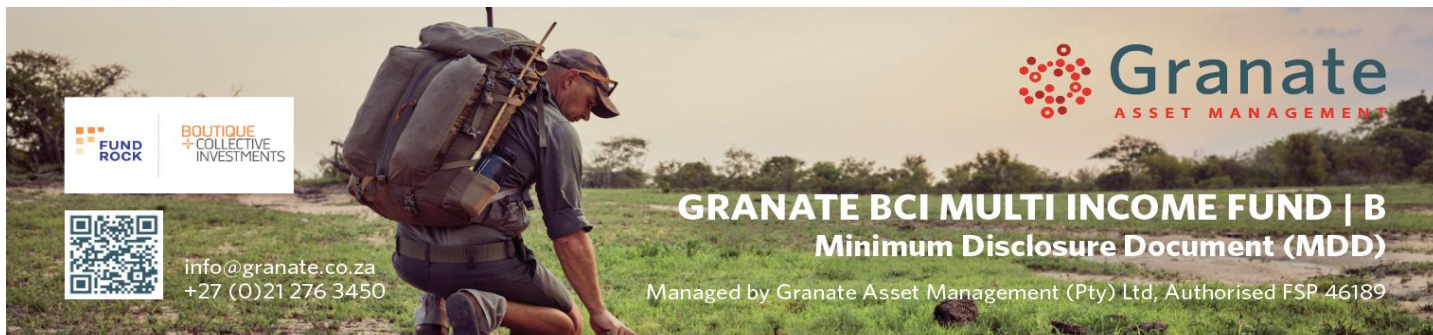
