
Investment objective

The Granate BCI Flexible Fund's objective is to provide investors with medium to long-term capital growth.

Investment policy

The portfolio aims to achieve a return of at least CPI + 6% a year, measured over rolling seven-year periods. While it seeks to limit downside risk over the medium to long term, investors should be able to withstand short-term volatility. To achieve these objectives, the portfolio willI have maximum flexibility in terms of asset allocation and will not be precluded from continually varying its exposure to the various asset classes. The investments that will normally be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest-bearing securities, bonds, debentures, corporate debt, notes, equity securities, property securities, preference shares, convertible equities and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.
