

#### INVESTMENT POLICY AND OBJECTIVE

The Granate BCI Money Market Fund is a local money market portfolio that provides investors with a medium whereby they can obtain undivided participation in a diversified portfolio of money market instruments and assets in liquid form. The primary objective of the portfolio is to obtain a high level of current income as is consistent with capital stability and liquidity. Capital gains will be of an incidental nature. The portfolio may include interest rate swap transactions for efficient portfolio management purposes. The fund objective is to obtain as high a level of current income as is consistent with capital stability and liquidity.




